

Wisconsin Carry, Inc is a non-profit all volunteer organization dedicated to protecting and advancing the right to carry in Wisconsin. Our organization believes in the founding principles of our country and constitution: That all are created equal, that governments exist to protect the rights of individuals, and that governments derive their power from the consent of the governed. The Second Amendment of our Federal constitution explicitly affirms one of the limitless numbers of rights we enjoy as human beings. The right to keep and bear arms. In 1998 75% of the voters in the great state of Wisconsin voted Article 1 Section 25 into our state constitution. "The people have the right to keep and bear arms for security, defense, hunting, recreation or any other lawful purpose". We believe that "Open" and "Concealed" carry are choices to be made by law-abiding citizens based on what suits their needs best without permits, fees, or other infringements. Our mission is to preserve, advance, and expand this basic right which law-abiding citizens are entitled a practical ability to exercise.

Incorporated in late fall of 2009, Wisconsin Carry, Inc. has, through a results-oriented approach, grown to be the largest, most effective, independent in-state right-to-carry organization. We are 100% volunteer. We are devoted exclusively to advancing the rights of law-abiding Wisconsin Citizens to carry in the manner of their choosing without permits, fees, and other infringements - "Constitutional Carry". In this mission, we employ an "all of the above" approach that includes grass roots legislative activism, public relations/media outreach, civil rights litigation, and education. Wisconsin Carry has filed five successful lawsuits in Federal court on behalf of members who's rights had been violated providing tens of thousands of dollars in judgments. In the media, we advocate for the right to carry, having participated in hundreds of local, regional, national and international news media interviews including radio, newspaper, television, and internet. With grass roots activism, we were successful in getting "constitutional carry" introduced and passed out of committee to the floor the Wisconsin Senate before it was amended to an expansive shall-issue bill that became Act 35 (Wisconsin's concealed carry law). We offer resources to educate and inform our membership and also offer a state-wide free training class that satisfies the concealed carry license "proof of training" mandate.
